- It is understood that MVC is the official videographer and all other videotaping may be done only at the discretion of MVC.
- After completion of video production, any re-editing of the video (per clients request) is subject to additional editing charges of \$65 per hour.
- Deposits are non refundable unless the cancellation is made and verified by MVC no later than 6 weeks before the dated ceremony. Amounts that are refunded will be minus a 10% booking fee of amounts received.
- MVC takes the utmost care regarding equipment function, recordable media quality, and recording. However, we will not be responsible for circumstances beyond our control, including but not limited to: power failure, equipment malfunction, defective media, lighting situations in which MVC

is not responsible for, acts of God. In the event MVC fails to comply with the terms of this agreement, MVC will only be liable for funds received. MVC will not be liable for damages exceeding that value.

- MVC reserves all rights to video production and may use original and/or duplicated videotape/s and/or digital files for demonstration, publication, or other purposes. Original videotape/s, digital files and copyrights remain the exclusive property of MVC. UNAUTHORIZED duplication and/or reproduction of this video is a violation of Federal copyright laws and STRICTLY PROHIBITED.
- Because of the massive amounts of hard drive storage video use, MVC cannot keep master files longer than 14 days after dvds have been shipped. Master tapes are held for 90 days. Any changes made after shipping may incur additional fees. After 90 days, any additional work will not be possible.
